2.1 Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 International Public License

2.1.2 Section 2 - Scope.

- a. License grant.

2.1.3 Section 3 – License Conditions.

2.1.6 Section 6 – Term and Termination.
